# Using the AFCFC to your Chapter's Advantage

As we mentioned before the AFCFC is here to help your chapter. It belongs to you the AHEPA Family so therefore we encourage you to use it. Please note that AFCFC offers on your chapter's behalf a number of Scholarships. Thus giving your chapter the opportunity to be more relevant in your Community by offering Scholarships to deserving students of Hellenic descent in your city. It also allows you to hold fundraising events and issue tax receipts using the Foundation's charitable number however, before using it, we have to point out some rules that must be followed.

- A. The chapter wishing to hold a charitable event and issue tax receipts must sign an agreement partnering with the Foundation.
- B. The donations collected must be sent to the AFCFC foundation along with the names, addresses and amount of each donor. These donations must be in the form of a cheque made payable to AFCFC from each individual donor to whom the tax receipt will be issued for. The payment cannot be made out by a husband wishing to have a tax receipt made out in his wife's name unless her name is also on the donation cheque.
- C. Only the net proceeds (e.g: entrance tickets) are tax deductible.
- D. The Foundation is obliged to prepare the final cheque of the total donation amount collected in the name of the licensed institution that you chapter is fundraising for.
- E. The Foundation is also obliged to send the individual tax receipts to the chapter's event organizers for distribution to the donors.
- F. For their administrative expenses, the Foundation is entitled to receive a payment of 5% of the total amount of donations they received until a maximum of \$700 is reached for each specific campaign.
- G. Please note that no tax receipts will be issued for any donation amount under \$25.

Brothers and Sisters,

As you know, no business or institution can survive and thrive without revenues. Brothers and Sisters we are such an institution. We have no operating revenues. While we do have money invested, Brothers donated these amounts with their specific wishes for the interest generated by that money to be used for Scholarships. Thus while we are proud to tell you that our Investments are doing well enough to cover the Scholarships, we are still operating revenues poor. The revenue that comes in is from the Montreal AHEPA Family's Valentine's Ball and in the some occasions from a few other Chapters. Not enough. Thank God for the generosity of some Brothers from the Board that cover most of the expenses from their own pockets.

This matter was discussed at the last Board meeting and the solution was to have a small fundraiser amongst us.... Meaning our members/shareholders. So it was decided that starting January 2020, we will ask every active Chapter of the AHEPA Family (Ahepa, Daughters of Penelope, Sons of Pericles and Maids of Athena) to contribute annually \$300 to the AFCFC Foundation's treasury to assist with the operating expenses and payment of any donations we are asked to give as a foundation throughout the year.

We find \$300 is a small amount to contribute in the Foundation's well-being. Please do not tell us that your treasury cannot afford it and does not have the money in the bank. You can hold a small event to raise that money or approach one of your members asking them to donate to Foundation and they will be issued a tax receipt (over \$25).

Please note you that your Chapter will be receiving an invoice for \$300 starting the first week of January 2020.

### A Proposal to the AFCFC and AHEPA Canada for new Horizons

**Brothers and Sisters** 

I have spoken to the Ahepa Canada Christos Argiriou and the Chairman of the AFCFC both about this idea.

Ahepa historically has always lead and taken on important causes that are relevant not only to Hellenism but the betterment of all mankind. We are defined by two words in our organization's name: **Education** and **Progressive**.

**Education** in terms of promoting learning, scholarly endeavors and the use of knowledge and its acquisition to advance the interests of mankind and Hellenism. In that regard education has as an integral component the promotion and encouragement of new knowledge and ideas.

**Progressive** in terms of being a leader being ahead of the norm and in terms of advancing our and society's interests by moving, promoting and acting with effort and resources on issues - be they political, social or other to improve the state of mankind, respond to problems and challenges in the world - given our roots in philanthropy, the promotion of democracy and social and economic justice. That is who we are and should be.

It was this emphasis upon education and progress that motivated the creation of our organization to combat discrimination and battle the KKK in the US and represent the interests of new Greek immigrants to the US who the subject of abuse and discrimination Ahepa evolved to be at the forefront of the promotion of civic rights, and causes both relative to Hellenism and the world in general both domestically, internally and as relating to Hellenic interests. We see this in our efforts to address disease, care for the elderly and the promotion of justice for Cyprus and other causes. Look at what our Montreal Chapter has done with events such as its Annual Valentine's day Ball where hundreds of thousands of dollars over the years have been donated to worthy causes mostly in the medical and health fields.

Ahepa's involvement is in response to the times and ills of the world as they happen and in this regard to keep to the goal of being **progressive**, we must consider what are the pressing needs and causes that are relevant today and imposing a huge burden and challenges on future generations. Ahepa is the ultimate poster child for the saying "wise men plant trees knowing they shall not live to enjoy their shade." In that regard we invest in and pay it forward to make things better for future generation.

We must also look at how we maintain our relevance and current appeal to what is important in the new generation from whom we also draw our membership. Like many organizations we are struggling to find new members and we are being identified as an organization for the old generation. We know this is not accurate but I would suggest we need to refresh our goals and objectives from time to time in the context of the pressing needs of the world. That is how we execute on our mandate defined by the actions required for **Education and to be Progressive**.

Ahepa and its members have always stepped up and taken on challenges. We now face a global challenge that threatens the future of our children and grandchildren.

One of the most pressing issues of the day is climate change and environmental issues. This is a cause we should embrace.

All polls indicate most voters and a larger number of young voters including millennials consider climate change an important issue to the extent that life on the planet can and will be impacted if action is not taken by governments in

this area. This is a new cause that would make us extremely relevant in today's world. The science which is real and supported by international organizations such as the UN, most progressive governments and leading thinkers in all fields is that of climate change. You need only turn on the news and look at the changes in our weather over the past few years around the world to realize something is going on.

This if we want to pay it forward we need to be worried about what the state of the planet will be that will be inherited by our children. The prospects right now do not look good.

The Greek affinity with the sea is historical. Promoting clean oceans and doing something about ocean plastic is important. I believe Greek shipowners (many of whom I have done and do legal work for I believe would support Ahepa).

We also should note that our own Ecumenical Patriarch Bartholomew is a leader in promotion of environmental issues and has written several books and articles and held and promoted conferences on environmental issues and their importance to mankind and a theological perspectives. I have worked in the environmental area for the past 25 years volunteering time as well as advising Canadian Foreign Ministers. My bio is attached in case you are not familiar with it. I want to do work in this area and have volunteered in recent years for award winning environmental causes such the OceanCleanUp - plastics initiative (see bio).

I believe the benefits of this initiative will be as follows:

- 1. Attract new younger members who have been proven to view this as an important issue;
- 2. Make us more relevant as to one of the most important causes facing the entire world;
- 3. Give us a good neutral cause to pursue politicians;
- 4. Allow us to distinguish ourselves from other Hellenic Groups;
- 5. Take the lead on this issue within the Hellenic Community;

I want both the Foundation and Ahepa Canada to consider and jointly appointment name as a: "Climate Change and Environment Advisor/Envoy" with the following mandate:

- 1. Advise Ahepa Canada and Foundation Executive on how we can engage on this issue
- 2. Prepare briefing material;
- 3. Arrange meeting with government officials and do a general lobbying campaign on this issue;
- 4. At some point organize a conference perhaps with the Patriarch on a climate change or environmental issue to be sponsored by Ahepa;
- 5. To undertake to education the Ahepa Canada membership, Daughters and Sons on this issue.
- 6. To form an Ahepa Family Climate Change Committee to help advance the cause.

I think not only could we and I lead on this in Canada but also internationally. I would be prepared to take on that role.
